**Blackledge/ Syal** subdivision off Summerfield Village lots # 21 and 22 green space. Syal is selling greenspace portion to Blackledge. Property is to be used only for greenspace, not for any building or structures. Pat Lavelle has copy of planning minutes, will take care of the wording and incorporate into the document. Tom Wicks asked should Malcom approve this evening and Malcom said no.

Tom is to check with Mrs. Syal with the activity on property, only shrubs were being planted. He has not had any recent conversation with her that this is only a greenspace that she needs to understand not her to build on lot. Syal is aware per Tom Wicks. Tom Wicks must keep this on his radar.

**Mrs. Wydeen** – Resident for 28 years of Glenburn.

Issues with large tractor trailer's on South Turnpike Road. Plummer business located in Dalton Borough has grown and due to the business area growing and expanding, mobile office, tractor trailers and cars are on property. Tracker trailers are coming in through Dalton for business and going out S. Turnpike Road in Glenburn causing more truck traffic and wear and tear on our roads that are not able to handle the weight. This is a Penn Dot Road. Dalton is not of any help and Penn Dot has not come and Post signs about weight limit for safety. Her husband Don Wydeen is gathering information from all (Penn Dot & Dalton) There is no code enforcement officer. Bill Wicks told Mrs. Wydeen that it is a huge process to put signs on Glenburn Roads about weight limit. Supervisors agreed to send letter to Frank Bullock the Dalton Solicitor to help on this matter. Keep us informed in this situation.

**Laurel Acres** resident complained of foresting behind her home and the noise. Tom wicks spoke to resident that was clearing and asked to start later in morning.

**Resign Columbo Pine Tree sub-division map.** Oct 2013 it was not filed in 30 days of so it can be submitted to Lackawanna waiting for Dave Jennings to return to sign also. Bill Wicks motioned to resign Pine Tree sub-division and Mike Savitsky 2<sup>nd</sup>. All in Favor. Have Dave Jennings sign when he gets back
