### **Planning and Old Business:**

**Syal Property and email from DEP Carl Deluca**

**Tom spoke to Jerry Stiles per Malcolm –**

Stated Jerry Stiles has reported to that Santa Syal property 2/3 of land mulched and seeded. Needs to be completed and bring back to the way it was on retention pond. Not just how it is now but how it was before it was seeded. Interesting, DEP with meeting with Ms. Syal. She states that she is no longer planning construct or to build anything on this lot. Carl DeLuca and Mr. Miller are in touch with her to complete and meet with Our Engineer and made sure look over the drawing from the builder from before this was all done. Want approval from board to have Jack Scheuer look over about all this work she has done of where it was and where it is now... Mal has not spoken to Greg Pascale yet and will make sure to get in touch with him and also meet with Ms. Syal, to enlighten us on her plans. Mrs. Sally Blackledge also asked if Ms. Syal has hired an engineer.

Our concern is that she asked about what kind of fencing to put around the retention pond and Mal told her the big issue is if any child get hurts and legal issues against her.

Also to meet with Baldoni to figure out what they have done.

### **New Business:**

Little league has filed a conditional use for lights at the ballpark. Came in to Tom Wicks and they said it is not conditional use and should be a variance. Called Carson Helfrich to look over. Told Frank Bollock and they will withdraw it and refile. Once they filed they have a time clock. The Little League has to file a variance and go before the zoning board. Show proof of why they need a variance. We have 45 days when filed. Zoning hearing board will look over everything and make sure that what they want or if allowed.

Lynn Stansky stated that all notes from previous time the Little League wanted approval to upgrade the area they agreed there would not be lights. All this is the minutes from the time.

Lynn Stansky asked if they should retain an attorney for the neighbors that would be effected. Malcom said he cannot advise on this. It is up to them.

### Keisling Property –

Zoning issues will be needed to have Carson to give direction for them to move forward. And to move forward.

### Columbo property –

Moving forward - boundary agreement of what was sent to Atty. Pascale and copy to Malcom and the Little League has authorize and Atty Bullock has this along with the lighting issue should not be with any concern between the two items. Movement of trash and vehicles removed and cleaned up.

### Fords Pond Road Cable

Neighbors called about Comcast Cable connecting to their homes. Petition from residents – Mike Brust. Comcast told Mike it would cost \$15,000.00 to connect to his house. Multiple residences called Frontier will not do anything to update tire equipment. Comcast told resident it should be 10 houses per mile. They have 10 homes in a mile and 1/3. They have 19.

All neighbors has signed the petition. Bernadette from township told him to call Comcast.

Cable ends at trailer park. Gave us a copy of petition and maybe a calibration with Glenburn and Newtown.

He is not here to complain, exhausted all he can do. Bill Wicks asked if he told Comcast all the homes. Yes he did. Also there is more lots. Malcom said we can write letter to support them to the company and the rep that we do our contract with the cable company.

Zoning Committee opening :We are going to have two residents who want to join our planning board and Beth Scalpi Table till next month.

Barbara Williamson Fords Pond Road. The road is in bad shape. The crew has been filling in and the hole are 2 feet deep. Runners Bikers school buses. What are we planning? Bill told of cold patch. Filled craters. Temporary measure. We had a 10 year plan can only afford the 1<sup>st</sup> year. To pay for work from last year we have a \$300,000.00 loan. Plus \$100,000out of our account. Liquid fuels money and grants also. Barbara said it was 23 years ago for the last pave. Cold Patch. We will have the crew fix after school is out. Will develop a plan to do repairs. Fixing lanes to get us through.
