**Roads: Report from Mark Hopkins read by Secretary Treasurer Bernadette Menendez**

**The road crew in the last 30 days has been working on the improvement of the dirt and paved roads. Patching and resurfacing. Cleaning catch basins etc. Working on the MS4 storm water survey. Keeping maintenance on vehicles and equipment. There will be a need for some new equipment, weed eaters and a lawn mower.**

**The new equipment needed is - lawn mower, 2 weed eaters. The GMC 3500 needs new tires before winter, both plow trucks need new spreaders. The Ford F550 may need a new dump box. Also chains for all trucks to help in bad conditions.**

**Cost of estimate for driveway drain is \$1807.00 in front of Township Building.**

**24 inch spreader \$2,400.00**

P C had 2 meetings – May 25 and June 7, 2017. Application from Abington Little League for lights. After review of data submitted, it was determined by Planning Commission that the application does not meet technical merit of ordinance. Nor does it meet with the borough classification of plural that is implied throughout the ordinance for the township. And by unanimous decision and asked Mal to put a letter together and presented to zoning hearing board on July 10, 2017. Malcolm MacGregor said to would be transcript this week.

Lynn Stansky asked if letter is public. Malcolm told her not written yet. Does not have to get reviewed by zoning board. Cannot be altered or changed. Public meeting

### **Old Business:**

Syal property at Summerfield last Monday spoke to LCCD asked to do onsite inspection. Done on Friday. Top soil delived and spread. Grass seed planted and too early to tell is complete germination of seeds. It would

take a couple of weeks. If areas not seeded they will be instructed to reseed those areas. Some trees planted, do not know what type. Tom is waiting on another inspection.  
Malcolm spoke to the LCCD and told them what the residents have said and understanding for them to have the onsite inspection and keep in touch with the neighbors.

Documentation to residents – Bernadette is gathering the info for them.  
There are different opinions of residents. Glenburn has sent out the engineer to look at area of Summerfield and has spoken to Badoni’s lawyer also. He will follow up with all of this for the way things were handled in our township.  
Peter Frosini said - Only trees around pit. Water does not flow, not moving or cultivated.  
Malcolm asked for neighbors to leave their phone numbers so he can keep in touch with the issues and he can relay to LCCD and DEP.
