- Approval of Minutes

-Committee Reports

Roads: Bernadette reported on the road report for May

The road crew has been attending to and maintaining the equipment necessary to keep roads safe and clear of debris. Patching potholes, cutting and trimming branches for clearance. Starting the lawn maintenance around the township building. Resurface dirt roads and also fill in pot holes.

Ask if they could get Waterford dirt road widened. It is difficult for truck and larger vehicles to go over it.

Bill wicks said we should have numbers on renting equipment to do the road work that is required to do the resurface of the roads. Money and man power limits the township.

Public Input:

Mr. James questioned about the road condition on Fords Pond that was not paved last year. Suggested a sealing company to come in to do the sealing.

Crew will be out to do this in house.

Mr. James complains that we should have done paving for his road. Mr. Bill Wicks said we can do all the roads and do a tax assessment to each resident for third share for each section. The township does not have the money to do everything and took the instructions from Jack Scheuer. Discussion continued regarding the way to manage the repairs.

Mike Roth from Chapin drive commented they have chunks of asphalt on their road with ruts of 6 to 8 feet wide and deep. Chapin is the highest priority. Bill Wicks stated, it will corrected in house to get us through. Renting equipment longer to include the major problems. Waiting on the prices for the next meeting from supplies that rent the equipment needed.

Syal - Malcolm spoke to Dist. Manger of the DEP on Ms. Syal. Carl Deluca – corrective action has begun, seeding and mulching. Tom told Malcolm that Jerry Stiles will be there in 10 days. Interested from neighbors about what they see. Pending final inspection.

Peter Millett – said the Mr. Badoni told him that cat and 9 tails should have been planted there. Mr. Blackledge said that she planted fruit trees that the deer have already started to eat the trees.

Resident Peter Frosini from 1018 Summerfield asked if the supervisors have gone to see the destruction. He offered for them to go through his property, Dave Jennings said he would take him up on the offer.

All the residents said that she did not reseed.

Tom said that the work has been done satisfactorily. But they will be back in the spring to continue.

Mr. Blackledge said according to his deed, they are a planned community, a legal document. He is wanting to know where we go with the plan since the plan was modified. Lots 21 and 22 are parts of the planned development. How did they go through with the sales of those lots?

Resident asked the board what is being done about the trees that were cut down and are supposed to be replaced. Malcolm stated that Jerry Stiles and DEP people are coming back out and he gave his email to the resident to get the copies of the pictures he has of the land that is baron.

We work with the residents to get the DEP to keep up and come to us with complaint from residents.

They will be presenting their plan to show what they would like to do.

Lynn Stansky asked what they plan to do if they are in violation of the zoning ordinance. The zoning board is meeting on July 10, 2017
