Public Comment Period: Supervisor Davis asked if anyone would like to comment on any items on the agenda? Allison Hall of Pine Tree Drive.

She is also concerned because she had a new drainage pipe put in at the end of her driveway this year and now they are digging it up and redoing all the work. Supervisors advised her that it will all be an overall improvement. Supervisors will check with Zach Smith about the updates.

Wyndwood Road: Peter Tierney regarding the Storm drain across from his home . He spoke with Road Master Mark Hopkins regarding the drainage problem.

The water comes from the property across the street , the drainage pipe from the gutters goes into the storm drain. The water is going under the township road. Supervisor Davis will go with Mark and see what needs to be done and have Mark look at the drain and clean out if they can get to it. The Township will look into it further.

Park Blvd : Diana Fenwick and Eric Van Gorder regarding the water from the Water company property. She went to the county roads and bridges, and they do not have anything to do with the roads there. Then She went to Penn Dot, and they also told her they do not have anything to do with the roads in the township. Also called up State Representative Haddock office. They are complaining that the leftover paving materials from the paving on Seamans Rd made the water rush down with more damage. The pictures were shown to the supervisor by Eric Van Gorder. Both entrances from the water company have drainage from the heavy rain. Supervisor Davis said he will talk to Mark tomorrow.
